### **About the Programme**

The CDN Governance Programme provides support to College Board Members and Governance Professionals. The programme has been developed to provide a full range of continuing professional development activities from inductions for new Board Members to training and guidance in specific areas of governance.

CDN also provides in-person training for boards and a range of bespoke support. This is listed in the table below.

#### **Board Workshops**

We also offer sessions on questioning skills, chairing skills and quality processes, as well as a session on working with the board for senior managers.
